5. Old Business

A. Financial Report December 31, 2013

Chair H. Schibanoff sent a report to all members. There were a few larger

expenditures. P. Nichols asked about Stratum Tires and D. Empey asked about landscaping, S. Jasper asked about the dumpster. Vice Chair J. Barnes will check into this.

B. Scout Project List

P. Nichols sent out a copy of the listing that had been discussed at the last meeting. R. Alio said he felt we had decided to keep the Trail project in place because it could be done with a walking tape to describe trees, flowers, and some history of the park. The Girl Scouts did a similar project and the tapes are available at the Library. P. Nichols also made a suggestion to table this list until the Committee Spring walk-around. This would show more projects for our Scouts and projects for the committee to plan for the spring and summer months. J. Leone asked if it would be wise to pencil in a time for the walk-around. K. Bowen thought the end of March could be a viable time, as

there is usually a thaw. D. Empey suggested waiting until our first meeting in March to choose a day for the walk-around because we would have a better view on weather situations. This will be an agenda item in March.

D. Empey asked to return to the budget pages and he seems to think he knows why the added budget items were attached to Benson Park. He believes we are being charged for the clean-up of the old dump behind Hazelton Barn. D. Empey thinks this charge should be paid by the Senior Center. The State was supposed to clean this area but when the Town wanted to purchase land for the Senior Center/HCTV Access Center, this was in lieu of paying for the property. Vice Chair J. Barnes will speak with K. Carpentier about this.

6. New Business

Vice Chair J. Barnes mentioned that terms expired and should we vote now or in April. After discussion it was agreed to vote on Officers at this time. Vice Chair J. P. Nichols welcomed S. Jasper and K. Bowen. She is very glad they are here. She is looking forward to a great year with lots of work. Congratulations to all newly elected Officers and anyone that would like her position please feel free to speak up. She is thrilled at what has been accomplished through the years and is still happy to be here. **A. Desrosiers** has not had a chance to go into the park to snow shoe but is looking to an opportunity for more snow. She also heard that a Bakery would open soon near the parameter of the park and they are going to continue with the Benson name which will be interesting. Just waiting to see what they will offer.
