PURPOSE OF PLAN: To depict the proposed mixed use plan which involves constructing a 10,000 +/- square-foot restaurant, 48 residential dwelling units, and other associated site improvements.

COMMENTS & RECOMMENDATIONS:

BACKGROUND

The site is approximately 6.43 acres and is located in the Business zone. The proposed site has never been developed. A relatively large wetland area encompasses the southern portion of the property as shown on the conceptual plan. No part of the site falls within designated flood zones, nor are any easements marked on the plan. The applicant intends for access to be provided via an easement onto the Wal-Mart drive located on Map/Lot 228-006-000, to which Wal-Mart has tentatively agreed to.

DEPARTMENT COMMENTS

Engineering had provided the following comment:

1. Applicant should look into pushing the 48 unit building back and creating parking for the building in front of it, separate from the restaurant parking.

SP# 03-24 Staff Report Page 1 of 2 2. Applicant should look into underground stormtech chamber system under the parking area to reduce the aboveground storm water detention area.

Fire has provided the following comment:

1. The site plan submittal provided by Meridian Land Services Inc. is incomplete. The applicant needs to provide a complete site plan showing fire department access for both the restaurant and the apartment building. The site plan also needs to show a fire hydrant location plan for both the apartment building and the restaurant. The proposed site needs to conform to the State Adopted Fire Code NFPA 1, 2018 edition, chapter 18, fire department access and water supply.

Staff notes that this is a conceptual site plan, and not a full site plan proposed for approval.

Full Comments can be found in Attachment "B".

STAFF COMMENTS

Due to being a conceptual site plan, many details related to the project are currently unknown. In broad terms however, the site is one of the few remaining undeveloped business lots in town capable of hosting the large amount of traffic a destination restaurant may generate. It should be noted that a significant proportion of the proposed parking lot is within the required 100 foot buffer. How this area would be dedicated to residential parking is unclear. It should also be noted that the proposed residential density appears to exceed the maximum allowable for the site with 48 units whereas only 45 units permitted. Consideration should also be given to delineation of drop-off, package delivery and loading areas for both uses, landscaping, including interior parking lot landscaping, internal vehicular and pedestrian circulation, and open space/outdoor recreation areas for the residences.

RECOMMENDATIONS

This phase is intended for discussion and Board input on the concept plan, but does not compel a Board vote of definitive action. This is an opportunity to anticipate issues that may arise during Site Plan Review, including dimensions, building placement, parking arrangement, and what waivers may or may not be required pending full Site Plan submission. Public comment is not required, as this is not a public hearing.

I) INTRODUCTION

The applicant, Lowell Rd., LLC, has requested to be heard at the Hudson Planning Board for a Conceptual Site Plan discussion at Lot 228-7. The project involves constructing a 10,000 +/- square-foot restaurant, and 48 residential dwelling units and other associated site improvements.

II) EXISTING USE

The property is currently vacant with a variety of ground covers and tree foliage.

III) SUBDIVISION

No changes to the property boundary are proposed under this application.

IV) STORMWATER MANAGEMENT

It is expected that the site improvements will trigger a NHDES Alteration of Terrian stormwater permit, therefore the site's stormwater will be designed to Env-Wq 1500: Alteration of Terrain. It is also understood that eh site will have to comply with the local stormwater ordinance outlined in Chapter 290 of the Town of Hudson Part 1: Administrative Legislation. The proposed plan has two areas reserved for stormwater management areas.

V) SITE ACCESS AND PARKING

The site is proposed to be accessed from the existing signalized access to Walmart. Walmart has preliminarily approved the site's connection to their access and will grant an easement to the project when it is appropriate.

The parking lot will be reconfigured to provide 219 +/- paved parking spaces. The parking will be shared with exception of the parking within the residential buffer will be restricted to be for the residential apartments.

VI) UTILTIES

The lot is proposed to be served by municipal water, sewer, and gas.

VII) LANDSCAPING

It is acknowledged that landscaping will need to be provided at time of formal submission.

VIII) SITE LIGHTING

It is acknowledged that a code compliant lighting plan will be provided at time of formal submission.



Your request: To develop a mixed-use property within the Business (B) district that abuts a Residential-2 (R-2) zone.

Zoning Review / Determination:

The restaurant and the multifamily are permitted in the business zone per <u>§334-21 Table of Permitted</u> <u>Uses.</u> Multifamily falls under the table of use category (A-3) and the restaurant is (D-15)

Mixed-use developments follow certain criteria regarding dimensional requirements, which can be found in the Table of Minimum Dimensional Requirements §334-27 <u>Table of Permitted Dimensional</u> <u>Requirements</u>. Minimum frontage shall be no less than the greater of the two uses' minimum frontage requirements. Multi-family homes (3 dwellings) with access to Town water and sewer require no less than 53,560 square feet of developable land, with each additional dwelling requiring an additional 5000 square feet of land. Developable land is defined as a contiguous area upland of wetlands and does not contain any steep slopes.

There would also need to be a Site Plan Review from the Planning Board per §334-16.1 <u>Site Plan</u> <u>Approval.</u>, contact the Planning Department at (603) 886-6008 for application details.
