#### 8. OTHER BUSINESS/CORRESPONDENCE:

- a. Karen Bohrer Rodgers Library Board of Trustees Treasurer attended meeting to ask several questions regarding Library funds held by the Trustees of Trust Funds, namely the Hills Memorial Library CRF, the Library Improvements CRF, the JN Hills Trust, and the AK Hills Library Trust. Also discussed was the Zelonis fund, which the Library Trustees have control of, however they do use the same financial institution as we do. Karen requested quarterly reports or updates if possible on the four fund balances we hold, and particularly next month for audit purposes. Karen was interested in the reimbursement process if the need arises to utilize the above four funds. We also suggested she attend possibly the next meeting when the advisor's present portfolio updates/outlook, etc.
