Other election results discussed were certain warrant articles that either passed or did not, the Trustees funds expect to receive in July from approved voter warrants a total \$515,000 for Town Capital Reserves, and \$300,000 from the School Capital Reserves. Also, some Town projects were discussed. The Trustees also discussed responsibilities of the "Bookkeeper" position of the Trustees of Trust Funds.

Motion to Appoint Steve Malizia for the Bookkeeper position of the Trustees of Trust Funds by Trustee Duchesne and seconded by Trustee Schibanoff, carried 2-0.

b. TTF Investment Policy for review, all Trustees were asked to review along with banking advisor's for any possible changes needed in order to sign off at next meeting.
